Representative Work

Public Policy. Obtained a defense verdict after trial in favor of a local public agency in a class action asserting the agency's toll collection and enforcement program violated the class's due process rights.

Public Policy. Defeated class certification in a putative class action against local public transportation agencies alleging that the agencies improperly collect and use personally identifiable information for purposes of collecting tolls.

Public Policy. Obtained a judgment in favor of a local public transportation agency in a putative class action alleging improper assessment of toll evasion penalties.

Wrongful termination. Won summary judgment in favor of a local public agency alleging whistleblower retaliation. The court found the agency had a legitimate, non-retaliatory basis for the termination.

Dangerous condition of public property. Won summary judgment in a challenge to the agency's design immunity for lack of a median barrier. The court found that technological advances do not strip the agency of design immunity where no dangerous condition exists.

Dangerous condition of public property. Won summary judgment in a case involving a bicycle accident on the agency's property. The court found the agency entitled to trail immunity.

False Claims. Won summary judgment in a qui tam action against a non-profit health care facility alleging violations of the False Claims Act.

Immigration Law. Secured a published Ninth Circuit victory on behalf of petitioner, a gay Nigerian client seeking asylum and protection under the Convention Against Torture in the United States.
