Jillian leads the firm's Health Section, while focusing on civil and regulatory litigation for health care industry clients and providers of long-term care services. Her representation encompasses health facilities and senior living, including skilled nursing facilities, hospitals, medical staffs, assisted living facilities, continuing care retirement communities, independent living communities, and intermediate care facilities for the developmentally disabled. She represents clients in litigation and administrative proceedings, such as license revocation actions. She handles all phases of litigation: discovery, law and motion practice, mediation, arbitration, administrative hearings, trials, writs, and appeals.

Jillian guides clients through issues involving multiple government agencies, including the California Department of Public Health, California Department of Social Services, California Department of Health Care Services, California Department of Justice, U.S. Department of Health and Human Services, and Centers for Medicare and Medicaid Services. She handles advice and counsel for disputes with government agencies and manages the response to investigations conducted by the same.

Jillian also works with hospitals and physicians on matters related to medically ineffective care. Jillian has litigated multiple emergency petitions under Probate Code 4735 and advised on situations involving the same. Jillian's hospital work includes supporting the client's team through complex discharges. She litigates complex discharges, where necessary, to help the team

achieve a safe and appropriate discharge.

As part of her work with hospital and medical staff clients, Jillian defends hospitals, medical staffs, and medical staff leaders in civil litigation arising from peer review activities. Jillian has represented multiple medical staffs in formal hearings involving peer review actions. Jillian has also served as a trial attorney representing hospitals in lawsuits involving peer review and physician contracting issues.

Jillian's prior experience includes representing companies in large-scale breach of contract actions, state and federal class actions, and state attorney general actions. Her representation has involved pharmaceutical and health care litigation, as well as consumer fraud actions.
