His work includes preparing and advancing complex residential projects under Senate Bill 330, the Builder's Remedy, Density Bonus Law, and other state housing laws. He regularly advises clients on strategic use of these laws to maximize development potential, reduce discretionary risk, and capitalize on ministerial or accelerated approval pathways. Niran's hands on experience in drafting statewide housing legislation and shaping statutory reforms, including contributing to revisions of AB 1893 and other Housing Accountability Act updates, strengthen his ability to help clients interpret and

harness new legislative opportunities at the earliest stage.

In addition to housing, Niran frequently leads entitlement efforts for non residential and innovation sector projects throughout California. His experience includes advising clients on the complex land use, zoning, environmental, and infrastructure requirements associated with biotechnology facilities, autonomous vehicle testing and deployment sites, renewable energy and grid resilience infrastructure, and data centers. Across both residential and non residential projects, Niran also has significant experience drafting and negotiating development agreements, leases, and other supporting contracts with public entities.
