He also regularly appears at administrative hearings throughout California, and adopts communication strategies that address not only legalities, but common-sense considerations.

Sean and his team have helped entitle millions of square feet of development throughout California, including affordable housing projects, wineries and vineyards, mixed-use development, data centers, regional hospitals, laboratories, pharmaceutical campuses, shopping centers, office campuses, infrastructure projects, terminal expansions, solar energy projects, and intermodal transport facilities at California's busiest ports.
