KRISTINA LAWSON APPOINTED BAY AREA COUNCIL'S NEW BOARD & EXECUTIVE COMMITTEE CHAIR





CLIENT SUCCESSES

From landmark victories to securing the best possible outcomes on behalf of our clients in highly complex and contentious deals, we're consistently providing world-class legal services to meet our clients' goals, build relationships, and enhance our overall reputation. Below is a sample of hard-fought wins in 2023.

CONSTRUCTION	Hanson Bridgett partners Andrew Giacomini, Lisa Dal Gallo, and Alan Bishop successfully represented University of California San Francisco (UCSF) in construction-defect litigation against UCSF's contractor for the design and construction of a Cardiovascular Research Building – a 233,000 square-foot custom-designed research facility. Through months of negotiations, Hanson Bridgett secured, on behalf of UCSF, a settlement worth approximately \$38 Million under which the contractor agreed to correct the defective construction.
LITIGATION	Hanson Bridgett partner Maggie Ziemianek secured a high-profile anti-SLAPP motion victory on behalf of Ashley Gore in a suit brought by the musician known as Marilyn Manson. The Los Angeles Superior Court agreed with the co-defendants (Gore and Evan Rachel Wood) that the defamation claim and portions of the intentional infliction of emotional distress claim arose from protected conduct. The Court agreed that Brian Warner (f/k/a Marilyn Manson) failed to demonstrate that he was likely to succeed in pursuing those claims against either defendant, including his claim that the defendants coerced or pressured anyone to make false accusations against him.
GOVERNMENT	A litigation team led by partner Alexandra Atencio secured dismissal of a putative class-action lawsuit on behalf of long-time clients the Golden Gate Bridge Highway & Transportation District and the Bay Area Toll Authority . Because the plaintiff lacked a viable legal theory to pursue at trial, the court vacated the trial and stated it will issue judgment in the agencies' favor. This is a decisive victory for the toll agencies after a protracted litigation process that lasted nearly six years.
LABOR & EMPLOYMENT	A team led by partner Sandra Rappaport successfully defended Leprino Foods Company , the world's largest mozzarella cheese maker and top producer of whey protein and dairy ingredients, in a class action in which the plaintiffs sought more than \$100 million for alleged non-compliant meal and rest breaks at the company's largest plant in Lemoore, CA. The case was tried to a jury in Fresno, CA and after the nearly month-long trial, the jury found for Leprino Foods on all claims.
REAL ESTATE (TRANSACTIONAL)	A team led by partner Anita Zerounian assisted a client in selling a portfolio of senior care facilities in Texas for over \$76 million . The sale included nine facilities with approximately 1000+ beds of assisted and skilled nursing in the greater Dallas metropolitan area. As part of the transaction, the buyer assumed a \$57 million non-recourse, permanent HUD insured financing with interest rates below 4%. The portfolio was rebounding from the Covid-19 pandemic and the buyer unlocked potential upside with the purchase and assumption of a very favorable HUD insured loan.
 REAL ESTATE (LITIGATION)	A team led by partner Jordan Lavinsky obtained a dismissal of a \$43 million fraud and breach of lease claim against our mixed use developer client and obtained a \$1 million judgment on our client's affirmative claims. In addition, the court awarded our client over \$600,000 in attorney's fees.
BUSINESS	A deal team from Hanson Bridgett led by partner Natalie Wilson and senior counsel Walt Binswanger recently represented client LOCH Technologies , a cybersecurity company and global leader of next-generation wireless threat monitoring, in its acquisition of Avirtek, Inc. The Arizona-based software company offers professional services and product development – including predictive Al/ML Data Detection and Response (DDR) capabilities. The integration between Avirtek's technology and LOCH's platform represented a significant advancement in the field of cybersecurity.
 HEALTH & SENIOR CARE	Hanson Bridgett partners Glenda Zarbock and Stefan Chacón secured a complete defense verdict in the Din v. Sutter Valley Hospitals litigation. The plaintiff sought over \$10 million in damages after he was suspended from the Sutter Davis Hospital medical staff and reported to state and federal agencies. Following several successful motions to narrow the issues, and defeating two ancillary lawsuits by the same plaintiff on dispositive motions, the case culminated in a two-day bench trial in

to the plaintiff. The court later issued a significant cost award.

COMMUNITY CONTRIBUTIONS & RECOGNITION

Pro Bono Matters Matter

From staffing immigration clinics and assisting refugees with applications for citizenship and other immigration services to standing up for what's right and challenging a group of entitled bullies that were preventing families from accessing a public beach, Hanson Bridgett attorneys showed up for those that needed our support in 2023. Our expanded volunteer opportunities included community service projects and assisting nonprofits with vital services for those experiencing homelessness, among others.

Impact Hours

Hanson Bridgett attorneys and professionals found many ways to make positive impacts on their communities and the firm through Impact Hours. Whether through volunteering in their community, serving on organization boards or other community leadership positions, working on the firm's DEI initiatives, or promoting section knowledge and business development, our people contributed **more than 3,500 Impact Hours in 2023** (in addition to our pro bono work).

Pro Bono Week & Silent Auction

Not unlike the movie itself, this year's Barbie-inspired Pro Bono Week was a smashing success. Festivities included announcing our annual Pro Bono Award winners (congratulations to our 2023 Pro Bono Champions: Nancy Newman, Patrick Burns, and Sara Wright, and our Advocate of the year: Kendall Fischer-Wu). We also held a silent auction with fantastic prizes and lively receptions at our LA and SF offices. We raised more than \$35,000 in total for our partner organizations during Pro Bono Week and we contributed more than 3,500 Impact Hour in 2023 (in addition to our pro bono work).

Charitable Match Program

Over the past year, **Hanson Bridgett's attorneys performed more than 6,000 pro bono hours.** Firm employees (excluding equity partners) are eligible for Hanson Bridgett's matching program: donations to a single charity of up to \$1,000 are matched by the firm. The program offers employees the opportunity to maximize the effect of their individual donation to their favorite charities or one of our pro bono partners. This year, the firm matched \$15,000 in charitable donations from attorneys and administrative professionals and funded more than 100 organizations in 2023.

2023 Beacon of Justice Award

The National Legal Aid & Defender Association (NLADA) honors members of the pro bono legal community who are tireless advocates for equal justice. Hanson Bridgett is honored to be among the NLADA awardees for the firm's hundreds of hours of pro bono work, offering direct legal services to individuals related to LGBTQ+, gender-based, and racial equity.


